## **1 Applicability**

- 1.1 These Terms of Use apply to the use of the Apps.
- 1.2 By using the apps (including downloading and installing them), you accept as a user of the apps ("User") these Terms of Use.
- 1.3 The Terms of Use may also be consulted, downloaded, saved and printed on our website (<https://officebooking.com/en/conditions/>)
- 1.4 If the Apps uses third-party services, the terms and conditions, privacy and cookie policies of those third parties also apply. Officebooking is not responsible for the services and the privacy and cookie policies of third parties. In case of any conflict, these Terms of Use apply.
- 1.5 Officebooking can modify these Terms of Use from time to time.

## **2 License**

- 2.1 Officebooking grants the User a non-exclusive, non-sub-licensable and non-transferable license to use the apps. The user is not allowed to use the apps for commercial purposes.
- 2.2 The User may not make the apps available to third parties, sell, rent, decompile, reverse engineer or modify the Apps without prior consent of Officebooking. Neither may the User circumvent or delete technological measures designed to protect the apps.
- 2.3 Officebooking has at all times the right to modify the apps, to change or delete data, to deny the user the use of the Apps by terminating the license, to restrict the use of apps, to deny access to all or part the Apps on a temporary or permanent basis.

## **3 Use the Apps**

- 3.1 The use of the Apps is at your own risk.
- 3.2 To use the Apps, the User needs to arrange the necessary equipment, system software and (Internet) connection at their own expense.

## **4 Intellectual Property Rights**

- 4.1 All intellectual property rights and / or similar rights on the (content) Apps are held, to the extent that these rights are not held by a third party, solely and exclusively by Officebooking or its licensors.
- 4.2 The User shall safeguard the name and reputation of Officebooking and will ensure that its use of the Apps will not inflict damage in any way to the rights and / or the reputation of Officebooking.

## **5 Liability**

- 5.1 The Apps are compiled with the greatest care. Officebooking cannot guarantee that the apps will always be available without interruption, errors or defects. Officebooking reserves the right to discontinue the Apps (unannounced), temporarily or permanently, without the user deriving any rights from such an event.
- 5.2 Descriptions and images of some of the listed locations and objects in the Apps are from public sources. Although the content of the App has been created with the utmost care and Officebooking strives to provide current, accurate and complete information, Officebooking gives no express or implied warranty that the current information provided on the Apps is correct and complete. The User accepts that access to and use of the Apps, as well of use of the information contained in the Apps, is the sole responsibility of the User.
- 5.3 Officebooking is not liable for damage or injury resulting from the use of the Apps.
- 5.4 The User shall indemnify Officebooking for all possible claims of third parties arising from the use of the Apps. User will compensate Officebooking for all damages and expenses (including but not limited to (extra) judicial costs) Officebooking suffers as a result of such claims.

**6 Termination use the Apps by User**

The User may terminate the use of the Apps at any time by removing or uninstalling the app from their device.

**7 Privacy**

Personal data is stored only for the proper functioning of the Officebooking service. In our Privacy Statement we describe how Officebooking ensures the protection of personal User data.

**8 Governing law, dispute resolution**

8.1 These Terms of Use are governed by Dutch law.

8.2 Any disputes arising from or connected with these Terms of Use will be submitted to the competent Dutch court of law.

8.3 The Terms of Use have been drawn up in the Dutch language. Officebooking will upon request provide an English translation. In case of a difference in interpretation, the Dutch text shall be binding.
